While there are commercially available target butts, they are very expensive and not practical for a large competition with a limited budget – otherwise the entry fees would be too high and this wouldf significantly affect competitor numbers.

It was agreed that it is difficult to control Sport crossbow draw weights, and that the matter be referred to the Technical Committee.

Subsequent to the formal Council meeting in discussions with Edwin Hirte, there is the possibility of a WCSA European Target Crossbow Championship being held in conjunction with the German Field/Target Championships to be held in Ennigerloh in 2014. This event will be a combined IAU/WCSA competition.

Gunter Wetzler asked whether the WCDSA could provide financial assistance to future organizing committees to assist with the costs associated with obtaining quality target butts for championships, particularly for the Sport crossbows.

John Clark advised that this was not possible given the modest income of the WCSA, but that the Executive Committee has resolved to provide championship medals at zero cost to organizing committees. Medals are a significant part of championship expenses.
